## Harold E. Holt Area A (HEHA)

**2021 Annual Interpretive Report** 

In June 2018, Defence completed a Detailed Site Investigation to better understand the nature and extent of per- and poly-fluoroalkyl substances (PFAS) contamination on and in the vicinity of HEHA. The outcomes of the investigation were used to develop a PFAS Management Area Plan (PMAP) for HEHA and surrounds. The PMAP outlined how Defence would manage potential exposure risks to PFAS, as well as monitoring the distance PFAS has migrated over the years, away from where it was first used. This is done by measuring any changes in PFAS concentrations through the Ongoing Monitoring Plan (OMP).

### What is an Annual Interpretive Report (AIR)?

The Annual Interpretive Report (AIR) reports on and interprets the samples taken across a 12 month period as part of the PFAS OMP.

In the AIR, we use this information to assess whether it changes our understanding of the nature and extent of PFAS contamination in the area.



HEHA has had one previous AIR (for 2020) and we will continue to prepare AIRs to report on monitoring rounds completed in 2022 and onwards.

### The 2021 HEHA AIR

This AIR covers groundwater, seepage water, surface water and sediment sampling conducted between November 2020 and October 2021, from locations on and around HEHA. The AIR also compares the results of the new sampling to previous results.

### Number of samples collected and analysed from the 2021 AIR


Groundwater	Groundwater is water beneath the earth's surface. It often supplies bores, wells or springs.	57 samples collected from 31 groundwater monitoring wells
Surface Water	Surface water is water that collects on the ground and can be in the form of creeks, rivers, lakes, wetlands, oceans and more.	11 samples collected from 5 surface water locations
Seepage Water	Seepage water is water that is present in the ground and is moving between surface water and groundwater.	22 samples collected from 11 seepage water locations
Sediment	Sediment is made of broken down remains of rocks, minerals, plants and animals that is moved and deposited to a new location.	18 samples collected from 6 sediment locations

### What does the 2021 AIR tell us?

Based on the samples we collected and analysed we found that the nature and extent of PFAS contamination within the HEHA Monitoring Area is similar to previous results from sampling conducted between 2010 and 2020. The PFAS plume is likely being slowly diluted by rainfall recharge and groundwater migration.

We will continue to monitor every six months at the locations identified in the OMP, and will complete another review of monitoring results as part of the upcoming 2022 AIR.
