A message from Air Commodore Sandy Turner CSC, Program Manager

I recently had the pleasure of welcoming Singapore's Permanent Secretary for Defence to Rockhampton, briefing him on the progress of ASMTI and joining him on a flyover of Shoalwater Bay Training Area. From the air we viewed the Raspberry Creek Urban Operations Live Fire facility and Camp Tilpal. This visit was one of a number of Singapore Armed Forces (SAF) and Ministry of Defence senior leadership visits that occurred during Singapore's Exercise Wallaby 2023.

Whilst at Shoalwater Bay, I was invited to visit SAF's Motorised Infantry Live Firing exercise involving the SAF's Terrex Infantry Carrier Vehicles at one of the Combined Arms Air-Land Ranges built by this initiative. Under the ASMTI, from next year SAF training during Exercise Wallaby is anticipated to increase from the current 45-days, to 9 weeks a year.

Shoalwater Bay Training Area

Construction Update

Two major construction milestones have been achieved over the last couple of months. Both Raspberry Creek and Oakleigh Urban Operations Live Fire facilities are now complete, with permanent power source connected and the facilities handed over to Defence. The Australian Defence Force (ADF) and SAF will plan to undertake a program of test and evaluation activities prior to certification as safe and suitable for use, in advance of SAF's first use during Exercise Wallaby 24. Camp Tilpal and the logistics facilities at Precinct B are also nearing completion, and Defence's Managing Contractor, Laing O'Rourke, are progressively demobilising through to the end of the year.

Shoalwater Bay Training Area (Continued) Airspace Change Proposal

Defence has submitted a proposal to the Civil Aviation Safety Authority's (CASA) Office of Airspace Regulation and Approval for consideration of the establishment of restricted airspace over the expanded Shoalwater Bay Training Area. A revised proposal has been published on the Queensland Aviation State Engagement Forum for stakeholder awareness, with an outcome expected from CASA by the end of the year.

Greenvale Training Area Environmental Approvals

Since 2017, Defence has conducted detailed environmental studies on the land acquired for the establishment of the Greenvale Training Area, to understand its biodiversity, heritage and natural and cultural values. Those studies will enable Defence to sustainably manage the training area, by protecting and improving native vegetation, habitat and the survival prospects of native species by minimising access to sensitive areas, and actively managing threats such as pests, weeds, pathogens and bushfire.

Through the completion of those studies, Matters of National Environmental Significance were identified. Earlier this year, Defence referred the development and future use of the training area to the Department of Climate Change, Energy, the Environment and Water (DCCEEW) for consideration under the *Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)*.

In August 2023, the Minister for the Environment and Water determined that the off-site works to support the training area do not require approval under the EPBC Act. DCCEEW is currently considering the onsite development and future use of the training area. Once DCCEEW has validated the submission documentation, the referral will be publically accessible on the EPBC Act public portal. Upon completion of the environmental assessment and approval, works will commence on the delivery of facilities and infrastructure, including in accordance with any approval conditions stipulated by the Minister for the Environment and Water. Given the EPBC Act assessment process remains underway, we are unable to confirm the development schedule at this time.

We understand that this schedule uncertainty affects project stakeholders who are anticipating opportunities as part of this exciting development, and we will continue to provide updates and closely engage with stakeholders and community members. Greenvale Training Area (Continued) Airspace Change Proposal

In October 2022, CASA approved an initial proposal to establish restricted airspace for airspace directly over the Greenvale Training Area (designator R732). Defence is now preparing a second proposal for airspace outside and adjacent to the Defence boundary. The proposal is still being prepared, but will be published on the Queensland Aviation State Engagement Forum for a period of consultation prior to submission to CASA. This is expected to occur in Quarter 1 2024.
