#### **GREETING:**

WHEREAS, by Letters Patent dated 23 December 1999, We instituted an Australian medal, designated and styled the Australian Sports Medal, for the purpose of commemorating Australian sporting achievement in the year 2000;

AND WHEREAS the Letters Patent ordained that the award of the Medal be governed by the Australian Sports Medal Regulations set out in the Schedule to the Letters Patent:

AND WHEREAS it is desirable that the Australian Sports Medal instituted by the Letters Patent be extended to commemorate Australian sporting participation in certain multi-sport events;

AND WHEREAS it is desirable to make new regulations to govern the award of the Medal:

 $KNOW\ YOU\ that\ We\ do,\ by\ these\ Presents$  , declare Our Pleasure that:

- (a) the Australian Sports Medal is to commemorate Australian sporting participation in certain multi-sport events; and
- (b) the Regulations set out in the Schedule to the Letters Patent dated 23 December 1999 are revoked without prejudice to anything lawfully done thereunder; and
- (c) the award of the Australian Sports Medal is governed by the Australian Sports Medal Regulations 2020 set out in the Schedule.

# Australian Sports Medal Regulations 2020

# Part 1-Preliminary

#### 1 Name

These are the Australian Sports Medal Regulations 2020.

#### 2 Definitions

In these Regulations:

Australian citizen has the same meaning as in the Acts Interpretation Act 1901.

*declared multi-sport event* means an international sporting event declared under paragraph 4(a).

**declared nominating person** means an officer or employee declared under paragraph 4(b).

Medal means the Australian Sports Medal.

#### Minister means:

- (a) the Minister responsible for the administration of the Australian system of honours and awards; or
- (b) a Minister or member of the Federal Executive Council authorised by the Minister to act on behalf of that Minister.

### multi-sport event means:

- (a) one of the following international sporting events held, or to be held, in the year mentioned or any future years:
  - (i) the Invictus Games 2018;
  - (ii) the International Sports Federation for Persons with Intellectual Disability (INAS) Global Games 2019;
  - (iii) the Special Olympics World Summer Games 2019;
  - (iv) the Special Olympics World Winter Games 2021;
  - (v) the Olympic Games (Summer) 2020;
  - (vi) the Olympic Games (Winter) 2022;
  - (vii) the Paralympic Games (Summer) 2020;
  - (viii) the Paralympic Games (Winter) 2022;
  - (ix) the Commonwealth Games 2022; or
- (b) a declared multi-sport event.

#### nominating person, for a multi-sport event, means:

(a) unless paragraph (b) applies-a person in charge of the Australian team at the multi-sport event in the position of Chef de Mission or an equivalent position; or

(b) for a declared multi-sport event-a declared nominating person.

*previous Regulations* means the *Australian Sports Medal Regulations* set out in the Schedule to the Letters Patent dated 23 December 1999.

Note: The Letters Patent are published in Gazette Notice No. S 170, Wednesday, 5 April

Register means the Register kept under regulation 9.

Registrar means the Registrar of Awards appointed under regulation 9.

## 3 Interpretation

For each instrument made by the Governor-General under these Regulations:

- (a) the Governor-General may, in writing, on the recommendation of the Minister, amend or repeal the instrument; and
- (b) the Governor-General may provide for matters in the instrument by reference to particular matters or a class or classes of matters.

## Part 2-Award of Medal

#### 4 Declaration

The Governor-General may declare, in writing, on the recommendation of the Minister:

- (a) that an international sporting event that includes competition in different sports is a *declared multi-sport event*; and
- (b) that an officer or employee of a specified body organising the participation by one or more Australian teams at a multi-sport event is a *declared nominating person* for that multi-sport event; and
- (c) any conditions for the award of the Medal.

#### 5 Award of Medal

- (1) The Medal may only be awarded to a person (whether or not the person is an Australian citizen) who:
  - (a) has attended and participated in (whether or not they have competed at) a multi-sport event as an official member of an Australian team; and
  - (b) is nominated by a nominating person forthe multi-sport event; and
  - (c) meets the conditions (if any) declared under paragraph 4(c).
- (2) If a person nominated is also a nominating person for the multi-sport event, the Medal may only be awarded to the person if the matters in paragraph (l)(a) in relation to the person are verified by another person who:
  - (a) the Governor-General is satisfied is an appropriate officer or employee of the body organising the participation by one or more Australian teams at the multi-sport event to verify the matters; or
  - (b) is a declared nominating person for the multi-sport event.
- (3) A person who has already been awarded the Medal is not eligible for another award of the Medal.

### 6 Making of awards

An award of the Medal must be made by the Governor-General.

# 7 Design of Medal

The Governor-General may determine, in writing, the design of the Medal.

# 8 Wearing of Medal.

The Governor-General may determine, in writing, the manner of wearing the Medal.

## Part 4-Administration

## 9 Registrar of Awards

- (1) The Governor-General must, in writing, appoint a Registrar of Awards.
- (2) The Registrar must keep:
  - (a) a Register of the names of persons to whom the Medal has been awarded;
    and
  - (b) such other records relating to the award of the Medal as the Governor-General directs.
- (3) The Registrar may:
  - (a) correct an error in an entry in the Register of Awards or another record kept under this regulation; and
  - (b) change an entry in the Register of Awards in accordance with regulation 10 or 11; and
  - (c) annotate an entry in another record kept under this regulation.

#### 10 Cancellation of award

- (1) The Governor-General may, on the recommendation of the Minister, cancel an award of the Medal.
- (2) If an award of the Medal is cancelled:
  - (a) the Registrar must remove from the Register the ently relating to the award; and
  - (b) the person holding the Medal must return the Medal to the Registrar.

#### 11 Reinstatement of award

- (I) The Governor-General may, on the recommendation of the Minister, reinstate an award of the Medal that has been cancelled.
- (2) If an award is reinstated, the Registrar must:
  - (a) restore the entry that was removed from the Register; and
  - (b) return the Medal.

#### 12 Guidelines

- (1) The Governor-General may determine, in writing, on the recommendation of the Minister, guidelines for the implementation of these Regulations or a declaration made under these Regulations.
- (2) The Governor-General may, in writing, on the recommendation of the Minister, amend or repeal guidelines made under subregulation (1).

# Part 5-Transitional provisions

# 13 Transitional-Medals awarded under previous Regulations

- (1) This regulation applies to a Medal (the *Year 2000 Medal*) awarded under the previous Regulations before the revocation of those Regulations.
- (2) These Regulations apply in relation to the Year 2000 Medal as if it were a Medal awarded under Part 2 of these Regulations.
