Trial: Facts and legal principles

The offender was originally charged with 162 separate offences the majority of which were constituted by individual transactions that he was alleged to have effected using a Commonwealth credit card and his making of false entries in the Card Management System (CMS). At the commencement of the General Court Martial, the Prosecuting Officer made application to amend Charges 1, 2, 161 and 162 and to withdraw Charges 3-160. With the consent of the Defending Officer, the Judge Advocate allowed the application. The effect of the amendments was to roll up the allegations that constituted Charges 3-160 so that those allegations formed part of Charges 1, 2 and 161 and for Charges 161 and 162 to be renumbered as Charges 3 and 4. The offender entered pleas of guilty to four amended charges.

Sentencing: Facts and legal principles

During the period 25 July 2022 – 6 May 2023, the offender used a Defence Purchasing Card (DPC) and a fuel card on a total of 76 occasions without authorisation. Charge 1 involved the offender making 61 transactions to a value of \$39,584.33 using his DPC to pay for rent, pet expenses, electronic goods, furniture, car modifications, cleaning, internet services as well as other purchases. Charge 2 involved the offender making false entries in the CMS when acquitting those transactions. Charge 3 involved the offender on 15 separate occasions between 07 December 2022 and 07 May 2023 using a fuel card to obtain diesel from BP Australia without authorisation totalling \$1,891.57. Charge 4 involved the offender stealing the fuel card.

In respect of all charges, the Prosecuting Officer submitted that the offender's behaviour was deliberate, long running, motivated by greed and involved an egregious breach of trust. The majority of the purchases were for discretionary items and he compounded his offending by attempting to cover his tracks by falsifying entries when acquitting the transactions on the CMS.

It was conceded by the Defending Officer that the offender's behaviour was objectively serious, that it occurred over a significant period, it involved a breach of trust and was motivated by personal gain. Emphasis was placed on the psychological report and the opinions expressed therein, the early pleas of guilty, remorse and favourable character references. It was conceded that all punishments were available to the panel, including civilian imprisonment.

By imposing the respective punishments, the court martial panel concluded that they were the minimum required to satisfy the principles of general deterrence and need to maintain discipline and good order in the Defence Force.
