**2024 AUSTRALIAN DEFENCE FORCE ALPINE SNOWSPORTS CHAMPIONSHIPS (ADFASC) 11 – 16 AUGUST 2024**

**SITUATION**

1. The Australian Defence Force Alpine Snowsports Association (ADFASA) will conduct the annual Australian Defence Force Alpine Snowsports Championships (ADFASC) at Perisher Valley, New South Wales during the period 11 – 16 August 2024.
2. Contingents from each of the Australian Defence Force (ADF) Services are eligible to participate in the Championships. Each ADF Service has the opportunity to provide four teams comprising of male and female alpine skiers and snowboarders.
3. Ref A and B authorise ADFASA to conduct Alpine Snow Sports activities.

**AIM**

4. The aim of this instruction is to detail the conduct, administration and risk management for ADFASC.

**MISSION**

5. ADFASA conducts ADFASC in a risk appropriate manner to encourage development of ADF values through delivery of a safe, well-organised, alpine ski and snowboard competition.

**EXECUTION**

6. **Purpose.** To execute seven competition events, and two demonstration events, at ADFASC delivered through ADFASA management and risk ownership.

7. The objectives for ADFASC:
  - a. Determine potential team members for an ADF Representational Team for the British Combined Service Championships, currently scheduled for January 2027.
  - b. Determine contested individual ski discipline medals for each event:
    - (1) Giant Slalom
    - (2) Slalom
    - (3) Skier Freestyle (demonstration event).
  - c. Determine contested individual snowboard discipline medals for each event:
    - (1) Parallel Slalom
    - (2) Slopestyle
    - (3) Snowboard Giant Slalom (demonstration event).
  - d. ADFASC will also include a combined ski and snowboard event; the Combined Cross (CX), including an inter-discipline teams race.
  - e. Determine overall individual performance for ADFASC:
    - (1) Individual male and female ski champion rankings
    - (2) Individual male and female snowboard champion rankings.
  - f. Determine overall team performance:
    - (1) Overall male and female ski team champion rankings
    - (2) Overall male and female snowboard team champion rankings.
  - g. Determine the overall Service performance calculated via individual participant points.
