## Executive Summary

Fujitsu Australia Ltd (Fujitsu) is contracted by the Department of Defence to provide COMSARM® application sustainment and development services in the support of the Department of Defence.

Fujitsu's partnership with the Department of Defence is to deliver level 2 and 3 operational support, application maintenance, major and minor application enhancements to the Department of Defence.

Fujitsu has a long history of supporting COMSARM®. The latest contract was signed on 01 February 2020 with an original 3-year term. The contract term was recently extended until 31 January 2025. The approximate value of this contract at commencement was AUD \$13.2 million. The approximate value of the cumulative contract at renewal is AUD \$20.9 million. All work continues to be undertaken using Australian based, Fujitsu resources.

It is anticipated that one subcontractor may be engaged to provide augmented resources for Australian industry services, at some stage, during the term of the contract as illustrated in Table 1.
