2 Executive Summary

The Commonwealth has contracted Babcock as the Regional Maintenance Provider – West (RMP-W), supporting sustainment activities across multiple classes of vessels.

The Products Being Supported (PBS) include Anzac Class Frigate Helicopter (FFH), Arafura Class Offshore Patrol Vessel (OPV) and in 2025 the Supply Class Auxiliary Oiler Replenishment (AOR).

RMP-W provides maintenance management and technical services including:

- Liaising with the Commonwealth and suppliers to develop, program, coordinate, and verify maintenance delivery to meet demand;
- Establishing a robust, reliable, and resilient supply chain in the western region;
- The implementation of standard procedures and practices for maintenance across all class of vessels.
- Drive continuous improvement to enhance efficiency and effectiveness of maintenance; and
- Work with local industry to support the continued development of sovereign sustainment capability, over time.

The RMP-West contract requires Babcock to support Sovereign Industrial Capability Priority (SICP) Priority 1 – Continuous Naval Shipbuilding.

The RMP-W's role is to foster and support the industrial base to promote the 2017 Naval Shipbuilding Plan, consisting of four (4) key enablers to create a sovereign and internationally competitive naval shipbuilding and sustainment industry in:

- Naval shipbuilding and sustainment infrastructure;
- Naval shipbuilding and sustainment workforce;
- Australian industrial base; and
- A national approach.

Babcock's contract is for an initial 5-year term effective from 13 October 2022.
