Executive Summary

Leonardo was engaged in November 2013 to provide support to the SEA1442 Ph4 Acquisition project and associated 5-year Support contract. The aim of this project is to provide an upgraded communications suite for the Anzac class of frigates in operation with the Royal Australian Navy (RAN). This public plan is an update to the original version. It has been updated to reflect the change in focus since the original contract signature date and to address the updated Sovereign Defence Industrial Priorities (SDIPs) that are now in place.
